PM-DNP ENTRY OPTION 2: ADDING A NEW SPECIALTY

Course Delivery

The PM-DNP program is designed for the working APRN. The program is completed in 10 sessions and students may need to reduce work hours to accommodate completion of the DNP project (510 residency hours) and/or specialty clinical practicum (510 hours).

The Musco School of Nursing and Health Professions program blends three instructional strategies to produce an engaged learning curriculum. The first strategy is Immersion: our programs include a blend of virtual, hybrid, and/or face-to-face meetings in 1-4 day sessions. Immersion sessions are conducted up to three times during the program. During these immersion sessions, students may receive orientation instruction, work as teams with peers and mentors and participate in demonstrations, simulation exercises, assessments and/or evaluations. The second strategy is practicum experience: our programs include clinical and DNP project rotations conducted where the student lives or works. The third strategy is self-directed study: courses include online lectures, discussions, social networking, demonstrations, tutorials, readings, and/ or other homework. Most courses include additional real-time instruction via web conferencing, phone conferencing, and/or live chat sessions. Students may need to reduce work hour to accommodate completion of the DNP Project (510 residency hours).

Upon admission to the PM-DNP program, students who desire to add a specialty are required to submit a petition via their academic advisor by the end of the first enrolled session. Their Academic Advisor will then create a specialty program education plan based on the required specialty courses and additional courses determined as needed by the GAP analysis. Upon receipt of the petition, the Program Director will be notified and the student will be interviewed for admission to the specialty.

National certifying bodies require that all students applying for a new specialty must successfully complete 3 courses:

- 1. Advanced Lifespan Physical/Health Assessment
- 2. Advanced Lifespan Pathophysiology
- 3. Advanced Lifespan Pharmacology

Students are required to earn 3 credits in each of the 3 core courses to meet degree conferral eligibility and to sit for national certification exams. If a student has earned only 1-2 credits in an approved transfer course (through our internal transfer petition process), additional credits will be taken at University of Massachusetts Global to meet the minimum credit requirements for the degree. For students who are not awarded any or all of these course credits through the transfer Petition Process, these courses will be included on the student's educational plan. Upon completion of the DNP, including all courses required for the additional specialty, the student will be eligible to take the national certification exam for their chosen specialty offered by the American Nurses Credentialing Center (ANCC) and/or, the American Association of Nurse Practitioners Certification Board (AANPCB) to apply for licensure as an APRN in the state where they plan to practice.

Attendance: Students may be dismissed from the program at the Dean's discretion due to absence from required meetings.

Admission to the Program

Admission into the PM-DNP is twice a year in August (Fall 1) and January (Spring 1).

- Final application deadline for Fall 1, 2023 admission is June 15, 2023.
- Final application deadline for the Spring 1, 2024 admission is October 15, 2023.

- Final application deadline for Fall 1, 2024 admission is June 15, 2024.
- Final application deadline for the Spring 1, 2025 admission is October 15, 2024.

Admission Requirements

- Complete a Musco School of Nursing and Health Professions application available online at https://www.umassglobal.edu/nursing-health-professions (https://www.umassglobal.edu/nursing-health-professions/).
- Master of Science Degree in Nursing from a Commission on Collegiate Nursing Education (CCNE) or a National League of Nursing Accreditation Commission (NLNAC) accredited program with Advanced Practice Specialty (Nurse Practitioner [NP] or Clinical Nurse Specialist [CNS]).
- 3. National certification as an APRN or CNS.
- 4. Official transcripts from all regionally accredited institutions where post-baccalaureate coursework was completed or attempted.
- 5. Current and detailed resume or curriculum vitae.
- 6. Unencumbered RN license in the state where the student plans to do their clinical hours.
- Unencumbered APRN license in the state where the student plans to do their clinical hours.
- 8. Unencumbered APRN license is not required of CNS or other APRN if license is not required by their state to practice, or if in the process of taking national certification exam in specialty.
- 9. Personal interview with Program Director.

CastleBranch Requirements

All requirements are due by the end of the first session and are required to stay in compliance (current and updated) throughout their program. Students who do not start their specialty clinical practicum and/or DNP Project residency hours due to incomplete CastleBranch requirements will require a modified education plan, which may result in a program completion delay.

Immunization and Health Screening Requirements:

- · Proof of annual negative Tuberculosis (TB) screening:
 - · TB blood test (IGRA) OR
 - Negative chest x-ray <u>AND</u> a provider signed negative symptom checklist.
- Proof of completion of Hepatitis A and B immunization series or titer demonstrating immunity.
- Proof of two doses of Measles/Mumps/Rubella (MMR) immunization or titer demonstrating immunity.

- Proof of one Tetanus/diphtheria/acellular pertussis (Tdap) immunization (after 19 years of age) and boosters per the Centers for Disease Control and Prevention's adult vaccination schedule.
- Proof of Chicken Pox (Varicella) immunization or titer demonstrating immunity.
- · Proof of annual influenza immunization.
- Additional laboratory tests, immunizations, and/or documentation may be required for specific practicum sites.

Additional Requirements:

- · Annual Background Check clearance.
- · Annual negative 10-panel Drug Screen.
- · Annual CastleBranch Elearning (HIPAA/OSHA trainings).
- Copy of current CPR "Level C" Certification (Basic Life Support (BLS) Healthcare Provider) that will not be expiring in the next 12 months.
 - Certification MUST be an American Heart Association approved course.
 - Approved courses must have a didactic component AND skills verification component.
 - Online only courses, where skills are not validated by an instructor, will not be approved. Skills must be validated by an instructor using a feedback device that measures and provides real-time audio feedback or visual feedback (or both) on compression rate and depth.
- · Proof of unencumbered RN license.
- Proof of STUDENT NP Malpractice Insurance (\$1 million per occurence/\$3 million in aggregate).
- Any additional laboratory tests, immunizations, and/or documentation required by specific RN-BSN clinical practicum or DNP Project residency sites (e.g., proof of physical examination, proof of health insurance, etc).

Catalog Year

Students admitted to the Musco School of Nursing and Health Professions are admitted to the catalog year that is in effect on the date when they begin the program (either Fall I, Spring I).

Transfer of Coursework

University of Massachusetts Global awards a maximum of 40 semester credits as a block transfer from a regionally accredited MSN program toward the Doctor of Nursing Practice degree. Credits transferred as a block credit from the MSN may be transferred regardless of the year the courses for the degree were taken, which supersedes the University's seven-year rule limitation.

Degree Requirements for the Post Master's to Doctor of Nursing Practice Entry Option 2: Adding a New Specialty

To be awarded the Doctor of Nursing Practice Degree, students may transfer 500 clinical hours and a maximum of 40 credit hours from the MSN degree. Students must take all 30 credit hours of their Core Courses, which includes 510 clinical residency hours for the DNP Project, at University of Massachusetts Global. This program is designed to follow the guidelines and DNP essentials as set forth by the American Association of Colleges of Nursing (2006) and the National Organization of Nurse Practitioner Faculties (2013; 2014). All courses must be passed

with a grade of "B-" or higher. Clinical practicum and residency courses are graded on a Pass/No Pass basis; a Pass is equivalent to a "B-" grade.
